Allocation of Year 7 Places to St Bede's Catholic College for September 2026 start.

As St. Bede's Catholic College is over-subscribed, the criteria published in the Governors' Admissions Policy has been applied to allocate the 207 places that are available.

All applications submitted to the Governors and the Local Authority by the published deadline of 31 October 2025, and supported by the required documentation, within Priorities 1–6 have been offered a place. In addition, 16 applicants in Priority 7 have also been offered a place.

Four places have been allocated for students with an Education Health Care Plan.

Four applicants in Priority 7 and all applicants in Priorities 8 and 9 unfortunately have not been successful at this stage in securing a place with us for September 2026.

The college is happy to receive calls from families who have been unsuccessful in this round if they wish to know the priority group in which their application has been placed. It may be possible to make further offers if any family decides not to accept the place allocated to their child. Following first round offers, if requested, we will be in a position to give some indication of the likelihood of success with second round offers.

If your application has been refused, you have the right to appeal the decision of the Governing Body. To exercise this right, the completed appeal form and reasons for your appeal should be returned by Tuesday 31st March 2026 for the attention of the **Clerk to Governors, St. Bede's Catholic College, Long Cross, Lawrence Weston, Bristol BS11 0SU** or walkerc@stbcc.org

Appeals Procedure

Appeals for St Bede's Catholic College are arranged by North Somerset Council.

The Clerk to the independent appeal panel will ensure that:

- Appellants receive at least 10 school days notice of their appeal hearing.
- The appeal panel papers are sent to panel members and other parties involved within a reasonable timescale.
- Decision letters are sent within five school days of the hearing wherever possible.

Admission Appeal Timetable

Year 7 Admission – September 2026

2 March	Offers of a school place sent to parents and carers, including offers from other Local Authorities.
By 16 March	Parents and carers must respond to the offer of a school place.
17 March – 2 April	Details of those still seeking a place, including late applications to be exchanged between local authorities to enable a second round of allocations.
31 March	Deadline for appeals from on-time applicants.
15-17 June	Appeals to be held.

In Year Admission Appeals

Appellants have 20 school days from the date of notification that their application is unsuccessful to prepare and lodge their written appeal.

Sixth Form Admission Appeals

Where the offer of a place is conditional upon examination results, appeals will be heard within 30 days of the confirmation of results.
