St Anne's House is a 3-storey, detached, building, previously occupied by Bristol City Council Housing department. It is run by Bricks, a charitable incorporated organisation, for the benefit of the local community of BS4 and the wider West of England creative community.

The ground floor hosts community rooms, a community kitchen and cafe, a public living room, social subscribing rooms, gallery space, community sauna and creative studio spaces. Floors 2 & 3 are divided into shared office accommodation, hot desking areas and artist studios. There is a community gym situated on the 3rd floor. These areas are access controlled and not generally open to the public unless we are hosting an open house event.

It has a large car park at the front and a smaller yard at the back. These spaces can be used for community life events as well as fundraising, community and social activities.

It is our intention to operate a bar from the ground floor kitchen area on an ad hoc basis. We currently apply for a temporary license as and when required but the demand exceeds the number of temporary licenses we can apply for. This is to generate additional income to support our charitable aims
