An applicaiton to change the plans of the premises. To extend the opening hours and the hours of licensable activity as follows:

To alter / amend several conditions on existing licence

Remove - CCTV to be installed at the premises inside and out, to the satisfaction of the Licensing Authority and the Police. Tapes or recordings shall be kept for a minimum of 28 days and made available to the Licensing Authority and the Police upon request. The equipment to be maintained in working order and continually record during the operating hours and for one hour after. The correct time and date shall be generated onto the recording. If the equipment fails the Designated Premises Supervisor shall inform the Licensing Authority and the Police as soon as practicable, taking steps to remedy the problem without delay.

and replace with

CCTV shall be in use at the premises.

(i) Where a CCTV system is to be installed, extended or replaced, it shall be to an appropriate standard as agreed with the Licensing Authority in consultation with the Police.

(ii) The CCTV equipment shall be maintained in good working order and continually record when licensable activity takes place and for a period of two hours afterwards.

(iii) The premises licence holder shall ensure images from the CCTV are retained for a period of 31 days. This image retention period may be reviewed as appropriate by the Licensing Authority

(iv) The correct time and date will be generated onto both the recording and the real time image screen.

(v) If the CCTV equipment (Including any mobile units in use at the premises) breaks down the Premises Licence Holder shall ensure the designated premises supervisor, or in his/her absence other responsible person, verbally informs the Licensing Authority and the Police as soon as is reasonably practicable. This information shall be contemporaneously recorded in the incident report register and shall include the time, date and means this was done and to whom the information was reported. Equipment failures shall be repaired or replaced as soon as is reasonably practicable and without undue delay. The Licensing Authority and the Police shall be informed when faults are rectified.

(vi) The premises Licence holder shall ensure that there are trained members of staff available during licensable hours to be able to reproduce and download CCTV images into a removable format at the justified request of an authorised officer of the Licensing Authority or a constable.

(vii) There shall be clear signage indicating that CCTV equipment is in use and recording at the premises.

CCTV will cover entrances, exits and the external area to the satisfaction of Avon and Somerset Police.

Alter condition 2 to read There shall be no entry or re-entry to the premises after 02:00

Remove 3 a) If live music is to be played at the premises then it shall finish at 23:00 hours and shall;

b) only be played at the premises through a limiter suitable for live music which has been installed and set to a level approved by the Council through an authorised officer of the Pollution Control Team or;

c) only be non amplified music.

Alter condition 4 to read - NOISE CONTROL: Music shall not be played at a level that will cause a public nuisance to the occupants of any residential properties in the vicinity.

Alter condition 5 to read - Background music will be permitted outside until 23:00 Sunday to Thursday and 00:00 Friday & Saturday.

Alter condition 7 to read - NOISE LIMITING DEVICE: A noise limiting device shall be used in relation to all sound amplification equipment. The noise limiting device shall be installed and set at a level approved by the Council through an authorised officer of the Pollution Control Team on 23 August 2005.

NOISE LIMITER - CONTROLS:

a) The noise limiting device can only be reset with the authority of the Council through its authorised environmental health officer.

b) If deemed necessary, the noise limiting device shall be reviewed in conjunction with the council, through its authorised environmental health officer within fourteen days of notification

c) The noise limiting device shall be properly secured so that it cannot be tampered with.

d) The repositioning and/or replacement of the loudspeakers or the noise limiter/microphone may only be carried out after consultation with an authorised officer of the Pollution Control team together with the resetting of the noise limiter if appropriate.

Alter condition 9 to read - There is to be no consumption of alcohol in the outside drinking area after 02:00

Remove Condition 13 (The premises will operate in line with Inventive Leisure Plc operating schedule submitted to the Licensing Authority on 18 July 2005 or any amended version in operation from time to time. The premises licence holder shall give to the Licensing Authority not less than seven days notice of any proposed amendment to the aforesaid policy (including its deletion or its replacement) and shall provide to the Licensing Authority a copy of any amended policy prior to the change being implemented in the premises. A copy of the policy current at the time shall be provided to a constable or authorised officer upon request.)

Alter condition 14 to read Children shall only be permitted into the premises until 20:00 hours unless attending a pre-booked function or taking a table meal.

Remove condition 15 (The premises licence or club premises certificate holder shall ensure that potable drinking water is available free of charge at all times that any licensable activity is taking place. The drinking water shall be provided from the bar when such facilities are available. Notices publicising the availability of free drinking water shall be clearly displayed in areas accessible by the public.)

Alter condition 21 - Adequate and separate sanitary conveniences shall be provided as required by law in relation to gender identification purposes and shall be separately approached and adequately screened. The conveniences for each sex shall be indicated by a suitable notice. The sanitary conveniences in the premises shall at all times be kept in good order and repair, be properly and effectively cleansed, ventilated and disinfected, and supplied with water, paper and efficient flushing arrangements. During the time the premises are open to the public the sanitary conveniences and the approaches thereto shall be properly and efficiently lighted.

Remove condition 26 (An incident log shall be kept at the premises, and made available on request to an authorised officer of the City Council or the Police, which will record the listed matters including crimes, ejections, complaints, disorder, seizures, faults, refusals and authority visits.) and replace with
The premises licence holder shall require the designated premises supervisor, or in his/her absence other responsible person, to keep an 'incident/refusals logbook in either a bound book or online and in line with the premises licence holder's policy, in which full details of all incidents are recorded. This shall include details of any refused sales and shall give details of the persons involved, incident description, time and date, actions taken and final outcome of the situation. This shall be completed as soon as possible and in any case no later than the close of business on the day of the incident. The time and date when the report was completed, and by whom, is to form part of the entry. The logbook is to be kept on the premises at all times and shall be produced to an authorised officer of the Licensing Authority or a constable when required.

Alter condition 27 - On Wednesday and Thursday from 21:00 hours to the end of permitted hours the premises licence holder will risk assess at all times the need for SIA door supervisors. On Friday and Saturday and any Sundays before a Bank Holiday a minimum of two SIA door supervisors shall be employed at the premises from 21:00 hours to the end of permitted hours. The times and number of door supervisors contained in this condition can be amended in agreement in writing with Avon & Somerset Police.

Alter condition DC03 - The premises license holder shall ensure that the following details for each door supervisor are entered into a secure online portal kept for that purpose to include the following details: (i) Full name, (ii) SIA Certificate number

and/or badge number or registration number, (iii) The time they began their duty, (iv) The time they completed their duty. The register must be kept for at least 31 days and be available for inspection. [B] Additional details to be recorded include name, date of birth, address, contact telephone numbers, SIA certificate number, commencement date, and agency details where applicable.

Alter condition DC10 - The premises license holder shall require the designated premises supervisor, or in his/her absence other responsible person, to keep an 'incident report register' online and within company policy, in which full details of all incidents are recorded. This shall be completed as soon as possible and in any case no later than the close of business on the day of the incident. The time and date when the report was completed, and by whom, is to form part of the entry. The detail on the portal shall be produced to an authorised officer of the licensing authority or a constable when required.

Alter condition DC13 - DC13 When on duty, door stewards shall prevent admission and ensure departure of persons who are drunk and disorderly in a manner that does not cause further disorder.

Remove condition 10 of Annex 3 - On Fridays, Saturdays and Sundays before Bank Holidays a minimum of two SIA accredited door supervisors shall be employed from 21:00 hours until the premises close.

Remove condition - The CCTV system covering the external area will be enhanced to the satisfaction of the police, including installation of an additional camera to cover the entrance/exit.

To add the following conditions

1. The DPS will devise, implement, and maintain the following policies for the Premises:

- a. Dispersal Policy
- b. Security and Search Policy
- c. External area management policy

A copy of The Policies will be available to the Responsible Authorities on request.

2. A safeguarding policy ('The Policy') will be drawn up and implemented at the Premises.
