2. Using aggressive, threatening, foul or intimidating language to any person lawfully on Greenbank View.

6. Defaecating and urinating in public places on any pathways and highways including Greenbank View Road and the adjacent streets plus on any adjacent land including the school premises, cemetery, nursery school premises, wooded area and residents' gardens.

Power of Arrest

And the judge finding: That the conditions in section 4 of the Anti-social Behaviour, Crime and Policing Act 2014 are satisfied,

And the court being satisfied that: That the conduct consists of or includes use of violence.

A power of arrest is attached to this injunction whereby any constable may under the power given in section 9 of the Anti-social Behaviour, Crime and Policing Act 2014, arrest without warrant the defendant if the constable has reasonable cause for the suspecting the defendant is in breach of this injunction.

This power of arrest was ordered on 18 April 2023 and expires on 17 October 2023 unless before then it is revoked by further order of the court.

2. Using aggressive, threatening, foul or intimidating language to any person lawfully on Greenbank View.

3. Contacting either directly or indirectly, any resident of Greenbank View by whatever means.

4. Using any substances prohibited by the Misuse of Drugs Act 1972 in any part of Greenbank View.

5. Depositing waste and/or fly-tipping their rubbish on pathways and highways including Greenbank View Road and the adjacent streets and land including the school premises, cemetery, nursery school premises wooded area and residents' gardens.

6. Defaecating and urinating in public places on any pathways and highways including Greenbank View Road and the adjacent streets plus on any adjacent land including the school premises, cemetery, nursery school premises, wooded area and residents' gardens.

7. Storing wood underneath their vehicles and parking nose to nose with other vehicles so increasing the risk of fire and its spread.

8. Playing loud music, shouting, revving engines or making other loud noises which can be heard by the residents of Greenbank View between the hours of 23.00hrs and 0700hrs

A power of arrest is attached to paragraph 2 and 6 of this Order whereby any Constable may under the power given in section 9 of the Anti-social Behaviour Crime and Policing Act 2014 arrest without warrant the defendant if the constable has reasonable cause for suspecting the Defendant is in breach of any of those terms of this injunction.

The Court is satisfied that the conduct which is prohibited by this injunction consists of or includes the use or threatened use of violence and there is significant risk of harm to a person towards whom the conduct prohibited by this Injunction is directed.

This order shall remain in force until 17 October 2023 at 23:59 PM unless before then it is revoked by further order of the court

The court will reconsider the application and whether the order should continue at a further hearing to be attended at the County Court at Bristol, Bristol Civil Justice Centre, Number 2, Redcliff Street, Bristol, BS1 6GR on 30 May 2023 at 10:30 AM, time estimate 60 minutes.
