Introduction

Since the adoption of both the Core Strategy (June 2011) and Site Allocations and Development Management Policies (2014), the National Planning Policy Framework (NPPF) introduced the concept of 'Local Green Space' (LGS), which is retained within the revised NPPF. The designation of land as Local Green Space is a way to provide special protection against inappropriate development for open spaces which are of particular importance to communities. The NPPF requires that policy for the management of these designations should be consistent with those for the Green Belt.

To bring the policy and background evidence up-to-date, and in accordance with the NPPF, the Local Plan will introduce a designation of Local Green Space and a designation of Reserved Open Green Space. This is for other green spaces which meet the NPPF definition of an open space but do not meet the criteria for Local Green Space. Local Green Spaces have already been designated in Neighbourhood Development Plans in Bristol.

Purpose of this topic paper

This paper seeks to provide supporting information and justification for the inclusion of open space policies GI1, GI2 and others in the Local Plan.

This paper situates the policy within the national and local context and identifies the evidence available, including relevant policy and guidance, which informed the policy approach.

This paper will cover the following:

- The National Planning Policy changes since the adoption of the Core Strategy in 2011 in relation to LGS; and the role of the Local Plan Review; and
- Introduce the new policies used to manage LGS and ROGS in the city; and
- Detail the methodology the council created to designate LGS and ROGS; and
- The LGS and ROGS designations.

National planning policy background

The following section reviews the National Planning Policy Framework and Planning Practice Guidance to understand how this impacted the designation method for LGS and ROGS.

National Planning Policy Framework

Since the adoption of the Core Strategy (2011), the National Planning Policy Framework introduced the concept of 'Local Green Space', which is retained within the revised NPPF (2023).

Paragraph 101 of the NPPF (2023) states that Local Green Spaces should only be designated when a Plan is being prepared or updated; must be capable of enduring beyond the end of the Plan period; and that the designation of land as Local Green Space ought to be consistent with the local planning of sustainable development and be complementary to investment in sufficient homes, jobs and other essential services.

Paragraph 102 of the NPPF advises that a Local Green Space designation should only be used where the green space is:

- “in reasonably close proximity to the community it serves;
- demonstrably special to a local community and holds particular local significance, for example because of its beauty, historic significance, recreational value (including as a playing field), tranquillity or richness of its wildlife; and,
- Local in character and is not an extensive tract of land.”

Paragraph 101 states that policies for managing development within a Local Green Space should be consistent with those for Green Belts.

The NPPF also provides definition for Open Space as being: “All open space of public value, including not just land, but also areas of water (such as rivers, canals, lakes and reservoirs) which offer important opportunities for sport and recreation and can act as a visual amenity.”

Planning Practice Guidance

Planning Practice Guidance (PPG) provides supplementary information on the approach to Local Green Space and outlines the context to Local Green Space designation and its use in Local or Neighbourhood Plans. Paragraph 005 states that such designation ‘is a way to provide special protection against development for green areas of particular importance to local communities’.

The PPG identifies additional information in relation to the type of land that may be considered suitable for designation as Local Green Space alongside assessment principles for appraising Local Green Space. When identifying land suitable for review, the PPG defines that:

- Designation of LGS must be consistent with local planning for sustainable development in the area. Plans must identify sufficient land in suitable locations to meet identified

development needs and the Local Green Space designation should not be used in a way that undermines this aim of plan making (Paragraph 007).

- It will rarely be appropriate to designate areas as Local Green Space where the area has extant planning permission, unless development would be compatible with the reasons for designation or where implementation of planning permission is no longer feasible (Paragraph 008).
- Local Green Spaces may be designated where those spaces are demonstrably special to the local community, whether in a village or in a neighbourhood in a town or city (Paragraph 009).
- If land is already protected by Green Belt policy, then consideration should be given to whether any ‘additional local benefit’ would be gained by designation as Local Green Space. The example offered within the PPG includes Green Belt areas where protection from development is the norm (i.e. villages included in the Green Belt) but where Local Green Space designations could be used to identify areas that are of ‘particular importance to the local community’ (Paragraph 010).
- Different types of designation are intended to achieve different purposes. If land is already protected by designation, then consideration should be given to whether any additional local benefit would be gained (Paragraph 011).
- Green areas within new residential development that were planned as part of the development can be designated as Local Green Space if they are found to be demonstrably special and hold particular local significance (Paragraph 012).
- Whether to designate land as Local Green Space is a matter for local discretion, however the green area will need to meet the criteria set out in paragraph 100 of the NPPF (Paragraph 013).
- Proximity of the Local Green Space to the community it serves will depend on local circumstances (including why the green areas is seen as special), but it must be reasonably close (Paragraph 014).
- There is no lower size limit for a Local Green Space (Paragraph 016).
- Some areas that may be considered for designation as Local Green Space may already have largely unrestricted public access. However, other land could be considered for designation even if there is no public access (e.g. green areas which are valued because of their wildlife, historic significance and/or beauty) (Paragraph 017).
- Whilst a Local Green Space does not need to be in public ownership, the local planning authority should contact landowners at an early stage about proposals to designate any part of their land as Local Green Space (Paragraph 019).¹

¹ In 2019, the proposed Local Green Spaces made available for comment as part of the consultation on the new local plan; sites were identified and mapped in a consultation paper. Landowners are understood to be aware of proposed designations as a result of this extensive consultation process. 127 of the proposed Local Green Spaces are in Bristol City Council ownership. 47 are entirely or partly owned by other organisations, companies or individuals; these sites are all subject of long standing restrictive designations within the current local plan (Important Open Space).

- Land designated as Local Green Space may also be potentially nominated by the local authority as an Asset of Community Value (Paragraph 022).

The Planning Practice Guidance indicates that the type of land to be designated is a matter for local discretion, however, it provides additional guidance regarding ‘assessment principles’ for Local Green Space. These include:

- ‘Reasonably Close’: The proximity of a Local Green Space to the community it serves will depend on local circumstances, including why the green area is special, but it must be reasonably close. This is cited as within walking distance (Paragraph 014).
- ‘Not an Extensive Tract of Land’: The PPG recognises that there are no hard and fast rules about the size of an LGS, and judgement will be needed in designation. To align with the NPPF requirement, the LGS must not be an ‘extensive tract of land’, and consequently ‘blanket designation of open countryside adjacent to settlements will not be appropriate’ (Paragraph 015). Conversely, there is no minimum area for Local Green Space (Paragraph 016).
- ‘Public Access’: The PPG also states that public access is not a defining factor when designating LGS, and indeed, some areas may already have largely unrestricted access (Paragraph 017). Areas that may be considered for designation as Local Green Space may be crossed by public rights of way (Paragraph: 018).

In relation to open space, the PPG defines this to include ‘all open space of public value, [which] can take many forms’. These Open Spaces can provide health and recreational benefits, have an ecological value and contribute to green infrastructure; are important to the landscape and setting of built development, and are an important component in achieving sustainable development.

Policy Development Process

Core Strategy and Site Allocations and Development Management

The NPPF (2012) definition of Local Green Space was introduced after Bristol City Council had originally defined the scope of the Core Strategy (2011). The Core Strategy therefore did not make reference to LGS but instead referred to protection of open spaces which are important for recreation, leisure, and community use, townscape and landscape quality and visual amenity.

Policy BCS9 Green Infrastructure

With regards to Open Space, Policy BCS9 stated that:

“Open spaces which are important for recreation, leisure and community use, townscape and landscape quality and visual amenity will be protected. Some areas of open space may be released, through the development plan process, for appropriate development where:

- They are no longer important for recreation, leisure and community use, townscape and landscape quality and visual amenity;

- Development of all or part of an open space would result in improved urban form or an enhancement to existing open space areas...”

Policy DM17 Development Involving Existing Green Infrastructure

The Site Allocations and Development Management Policies (2014) was introduced after the publication of the NPPF (2012). Policy DM17 added further definition to Policy BCS9 and details the approach for its application in development management. With regards to Open Space, Policy DM17 identified Important Open Spaces which were shown on the Policies Map. The policy states that: “development on part, or all, of an Important Open Space as designated on the Policies Map will not be permitted unless the development is ancillary to the open space use.”

This policy will be replaced in the new Local Plan with new policies for Local Green Space, Reserved Open Green Space and Incidental open spaces.

Bristol Local Plan Review (February 2018 Consultation)

The 2018 consultation set out two proposals for the protection of green open space, the responses to these consultations helped inform the proposed designation of green open spaces:

- Proposal HW3 Specially Protected Green Space set out the type of land that would be permanently retained as open space. These Local Green Spaces were identified using a criteria based on local significance and would protect these spaces from development that would result in harm to the land’s open character or role.
- Proposal HW4 Reserved Open Green Space set out how development will not be permitted on these spaces unless it can be demonstrated that it is no longer required for its open space function, or a deficiency would not be created through its loss, measured against published standards for green space protection.

The role of this consultation and further consultation in 2019 played an important role in the designation of both Local Green Space and Reserved Open Green Space. It was decided that the designation of open green space should be undertaken with input from the community to ensure that these spaces are of public value and consultation was deemed to be an appropriate way to ascertain the extent of public value.

New Local Plan

The policies proposed in the new local plan are as follows.

Policy GI 1 Local Green Space

The local plan includes this policy to meet the national planning requirement to designate open spaces LGS should they meet a nationally created and locally defined criteria and be seen to be demonstrably special to the local community. This policy will give protection to designated green open spaces in the city and ensure that they are protected from development which would harm the green space’s character, role and appearance. It will however allow for ancillary development.

Policy GI 2 Reserved Open Green Space

This policy will seek to protect other green open spaces of community value. Development on these spaces is generally not allowed, however where a space can be seen to be no longer fulfilling its open space function and its loss would not lead to a deficiency of open space, development will be permitted. Like LGS ancillary development is allowed.

Other Local Plan Open Space Policies

The Local Plan also includes Policy GI3: Incidental Open Space which intends to protect smaller open spaces in the city which are less well defined in comparison with those designated LGS and ROGS. These spaces are commonly roadside features and townscape features. The plan will aim to protect these spaces unless the space is no longer locally important for recreation, leisure or for its townscape quality and visual amenity.

The plan will also designate Stapleton Allotments and Holdings as Local Green Space in Policy GI4 Stapleton allotments and holdings – food growing Local Green Space. In recognition of their special food growing importance.

Method for Assessment of Green Space

As set out above, there is clear distinction between the designation of Local Green Space and other open spaces within national policy, with the key difference being the permanence of Local Green Space beyond the plan period, which is reflected in how sites have been designated.

Green spaces were designated based on how they fulfilled the values of specially protected Local Green Space.

Summary of outcome

The outcome of the assessment is set out within **Appendix 1: Assessment Summary**; which indicates where sites have met the aforementioned criteria.

The following designations are proposed in the new local plan:

- 174 Local Green Spaces (1404.05HA)
- 406 Reserved Open Green Spaces (609.92HA)

Approach to designation

The approach to designating open space was informed by consultation and was refined throughout the plan making process. It comprised of 3 stages, set out as follows:

- Stage 1: Collating inputs.
- Stage 2: Interpreting each designation.
- Stage 3: Undertaking the assessment and refining the interpretations; public consultation.

Stage 1 Collating inputs

Stage 1 inputs comprised:

- Existing adopted Important Open Spaces: Defined within Policy DM17 of the Site Allocations and Development Management Policies.
- Sites that emerged through Local Plan Review Consultation: as Local Green Space may be designated where those spaces are demonstrably special to the local community, sites that emerged through the Local Plan Review consultation (2018 and 2019) were also appraised and feedback from the consultations played a key role in determining designations. This was to ensure that the Council has designated all open spaces of public value.
- Green Belt land was appraised to see what additional benefits could be gained through its designation.

Open spaces already designated through Neighbourhood Plan Areas within Hengrove, Lawrence Weston and Old Market were not appraised further because those plans contain the open space policies for the areas concerned.

For sites with natural environment designations, or those within identified Conservation Areas, the assessment method aligned with the PPG to consider the additional benefit that would be gained through their designation as Local Green Space or Reserved Open Green Space.

Stage 2: Interpreting each designation.

Interpreting Local Green Spaces within Bristol

For open space to be considered suitable for designation as Local Green Space, sites needed to be green and in close proximity to the community they serve, be local in character, and be demonstrably special to the community, which was interpreted as shown below in table 2.

Table 1 Criteria for LGS Designation

Criteria for sites to be considered for LGS designation	Definition
Close proximity to the community it serves	Given the specific urban characteristics of Bristol, most areas of green space are likely to be within easy walking distance of the community they serve. Larger open spaces may also enjoy a wider local catchment area than smaller more intimate spaces with less capacity and fewer facilities; this is particularly true of a space like Blaise Estate, which would be considered to have a city wide catchment area as a destination park.
Is local in character	In Bristol, open spaces tend to be contained within developed areas. Areas of open countryside are relatively small within the Bristol administrative boundary and tend to be located adjacent to the boundary to the south east and south west, which are designated as Green Belt, and to the northwest towards Avonmouth.
Is demonstrably special	Indicators of the demonstrably special nature of a green space were seen to be the existence of a friends' group, any recognised awards that the space may have received, use of the area by local community groups and instances where it has been the subject of recent local investment of time or money. The demonstrably special nature of the space was also seen to be indicated by a unique nature and character, or a special role and function that cannot be re-provided elsewhere.

NPPF Paragraph 100 also sets out five 'values' that help identify the special nature of open space. These 'values' were interpreted as the following within Bristol.

Table 2 LGS Assessment Matrix

Value	Criteria
Beauty	<p>Sites with high quality landscapes such as green hillsides, promontories, ridges, valleys, gorges, areas of substantial tree cover and distinctive manmade landscapes.</p> <p>Valuable urban landscapes, such as significant landscape views/vistas, key landmarks and historic gardens, which have an effect on the cities character.</p> <p>Sites mentioned explicitly and/or frequently within Conservation Area Appraisals or Enhancement Statement documents with an implicit reference to beauty value.</p>
Recreational Value	<p>Strong evidence of formal and/or informal recreational use(s), including a combination of cycle-paths; footpaths; skate-park or outdoor gym equipment; high-quality and well-used children’s play space; fishing and formal sports pitch/facilities.</p> <p>High levels of public accessibility and usage, defined by multiple public rights of way/access points into the site or spaces for passive recreation, including appreciation of viewpoints and seating areas.</p>
Tranquillity	<p>Public spaces with high levels of seclusion, demonstrated via natural and man-made screening such as a wooded edge or boundary wall, which enables a sense of tranquillity to be enjoyed, and,</p> <p>Limited, highly screened or no proximate urban detractors likely to incur noise pollution (including main roads, active railway tracks, industrial sites); and,</p> <p>Public accessibility to enable experience of tranquillity, defined by multiple public rights of way/access points into the site;</p> <p>Or: Size of area likely to hold sufficient level of tranquillity in and of itself.</p>
Historic Significance	<p>Site enables public enjoyment or experience of the setting or contributes to the significance of a Heritage Asset within site, including WWII memorial, Listed Building and/or,</p> <p>explicitly and/or frequently within Conservation Area or Enhancement Statement documents; and/or, Site falls within a Historic Park and Garden which is publicly accessible, or highly visible from public domain.</p>
Richness of Wildlife	<p>Multiple wildlife designations (i.e. LNR/ SPA/SAC/SSSI) which indicate high richness and biodiversity of wildlife; and</p> <p>High-levels of defined public access into site which allows for public appreciation of wildlife; and/or,</p>

	Site may include special facilities which allow the public to observe wildlife, for example, wildlife lookouts.

Interpreting Reserved Open Green Space

Reserved Open Green Spaces are considered to be those which do not meet the criteria for specially protected Local Green Space designation; however, they are defined as open spaces in NPPF terms, and the Local Plan will offer these spaces protection from inappropriate development. Reserved Open Green Spaces are those that hold current public value and are likely to include elements such as public access and local visual amenity. These spaces have been broadly assessed against the terminology within the PPG. However, unlike LGS, their functional use and/or public value may be subject to change.

Table 3 ROGS characteristics

Role	Criteria
Health and recreation	<ul style="list-style-type: none"> • Evidence of some recreational use (including allotments or school playing pitches); and, • Access to support an appreciation of the natural environment, or space to exercise and socialise.
Ecological and geological value	<ul style="list-style-type: none"> • Site contains a few lower-order ecological designations (i.e. not SSSI/SAC/SPA/LNR which would warrant consideration as LGS); and/or, • The open green space forms key part of a Wildlife Network Site (WNS) or identified formal Green Infrastructure link.
Urban landscape	<ul style="list-style-type: none"> • A significant connection to important landscape feature (i.e. hillside, gorges or areas with substantial tree cover); and/or • Contribution towards local visual amenity or local character, demonstrated via high visibility from the public domain and/or local views of the site.
Townscape and cultural heritage value	<ul style="list-style-type: none"> • Open green space contribution to local character, with the site being integral to urban design.

Stage 3: The Assessment

The assessment of green spaces against the Local Green Space ‘Values’ was made using a combination of aerial mapping, full consideration to consultation responses, Geographical Information System databases and physical site visits, and included such information as:

- Ecological Designations, including Sites of Nature Conservation Interest, Local Nature Reserve, RIGs site, RAMSAR, SSSI, SPA or SAC, and Wildlife Network Sites.
- Responses gathered from the consultations in 2018 and 2019.

- Historic and Landscape Designations, including Town and Village Greens; Registered Park and Gardens; Scheduled Ancient Monuments; Listed Buildings and Conservation Areas.
- Recreational sites, including Food Growing sites or Parks and Green Space Strategy sites.

Grouping of Open Space types

Following an initial review of open spaces, it was identified that sites could be broadly grouped into different types of open space, which meet the criteria defined in Stage 2. Defining open space types helped to guide the process of designation of sites by giving an indication of what type of space would be subject, in principle to either of the designations.

Table 4 Interpretation of Green Space ‘Values’ within Bristol

Typology	Description
Traditional / Multi-functional Parks	Clearly defined and formally designed spaces that offer a strong recreational benefit that includes a range of different uses. These parks are likely to provide tranquillity and have been designed have formal or natural beauty. They are considered an important feature for communities and meet a range of criteria. As such, these were generally considered to be appropriate for Local Green Space .
Destination Parks	These are large open spaces within the city boundary that provide a wide range of significant benefits for recreation, wildlife, landscape, GI and heritage. These spaces are not formally designed spaces but are likely to have been defined as Local Green Space for the unique and important role they serve.
Town and Village Greens	This status precludes any use of the land other than for recreational enjoyment. There is also the assumption that, through designation that the open space is inherently important to the local community and is likely to constitute Local Green Space .
Green Common Land	Open green spaces that are special to the local community and have Common Land designation was generally be considered to be appropriate for Local Green Space designation.
Local Nature Reserves	Spaces that have been given the designation of Local Nature Reserve due to providing distinctive habitats for flora and fauna. While the designation does not provide a national legal protection, it is a recognition of the unique importance of these spaces, and they have generally been considered to be appropriate for Local Green Space designation.
Allotments	The majority of the sites are protected under statutory allotment provision and part of the Allotment Strategy, but can include 'community gardens' or private allotment sites. A Reserved Open

Typology	Description
	Green Space designation was generally considered appropriate. The special characteristics of Stapleton Allotments have been recognised as LGS.
Educational Sites	Very few school playing fields have other intrinsic open space qualities beyond their role of providing for education requirements. These spaces were generally considered Reserved Open Green Space .
Sports Pitches/Fields	Spaces that provide an important contribution to sport activities in the city, but are not part of wider multifunctional spaces. The majority of spaces will not have further open space value beyond the sports provision and are generally proposed to be Reserved Open Green Space .
Townscape features	Spaces that have been designed as part of the wider street pattern or road layout and are often historical features on the street scene. These are distinguishable from more general road verges by virtue of their formal design and have been proposed as Reserved Open Green Space or would be considered as incidental open space where they are smaller or less prominent.
Churchyards and Cemeteries	Other open space benefits (such as recreational opportunities) are limited and this type of function would generally be considered to be a city wide requirement rather than offering a special local facility. As such, a Reserved Open Green Space designation was generally considered to be more suitable. In some cases, such as Arno's Vale, the beauty, role for quiet recreation and historic significance was seen to indicate Local Green Space.

Appraising inputs against typologies of open space and values of Local Green Space

Using the designations for context, the final stage of the assessment was to appraise open space against types within Table 5 above and the local interpretation of the values of Local Green Space.
