What is the Bristol Equality Charter?

Bristol Equality Charter is a city-wide initiative which has been codesigned by 20+ private, public and voluntary sector organisations in conjunction with Bristol City Council¹.

Although there are other relevant charters and manifestos the Bristol Equality Charter is unique because it is addresses equality in a way that is specific to Bristol and belongs to everyone in the city. The charter invites signatories to work together towards continuous improvement using a 'One City' approach².

Why sign the charter?

Being a signatory to the Bristol Equality Charter makes a clear public statement that your organisation is fully committed to the values of equality, diversity and inclusion.

Anyone can sign up to the principles of the Bristol Equality Charter for free – including individuals and any type of organisation.

Signing the charter is a voluntary action to promote and work towards equality in Bristol. Organisations are free to set their own specific priorities and goals for improvement - it is not an accreditation scheme or an award system.

Our signatories are committed to improving equality of opportunity for everyone in Bristol and to eliminating discrimination in all its forms. We acknowledge that we have a part to play in promoting equality for the city by working towards good practice and making continuous improvements.

How can we become a signatory?

When your organisation has agreed to commit to the principles of the Bristol Equality Charter, a signed and copy of the declaration form available at <u>www.bristol.gov.uk/bristolequalitycharter</u> should be returned to the Bristol Equality Network c/o
